WEST BANK

The Israeli army continues to intensify its restrictions at checkpoints set up on the main roads connecting the West Bank districts, thereby isolating the northern districts from the southern districts as well as the Jericho district and the Jordan Valley from the remainder of the West **ALL** Bank. **DISTRICTS** Since 24:00 on May 5, the Israeli army imposed an entire closure on the West Bank on the occasion of the 60th anniversary for the establishment of the state of Israel, and denied civilian access into the city of Jerusalem and the Green Line, except for previously arranged humanitarian cases. The closure will continue until May 17. Closure: The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem. The Israeli army also continued to close the entrances to al-Agsa Mosque compound in the old city of Jerusalem and impede civilian access to the mosque. **Closure of Main Roads:** The Israeli army continues to close the entrance opposite the junction to (i) Dahiyat al-Bareed in the city of Jerusalem with a barbed wire gate and to deny civilian access. The Israeli army continues to close the road connecting Dahiyat al-(ii) Bareed to the town of al-Ram in order to complete Wall construction in the area. (iii) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba', which connects the village to the cities of Jerusalem, Ramallah, and Jericho. Checkpoints: The Israeli army continues to consider Qalandya **JERUSALEM** checkpoint a "border crossing point" and has designated a special crossing for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem. Raids: The Israeli army raided the town of al-Izariyyeh and arrested 2 civilians (parent and son). Arrests: The 2 civilans arrested in the town of al-Izariyye are Mujahed Mousa Abu Roumi and his son Hakam. **Demonstrations**: (i) At 11:00, a public march set out in the refugee camp of Qalandia in commemoration of the 60th anniversary of the Nakba. Civilian protestors carried UN banners and demanded the implementation of UN resolutions related to the right of return of Palestinian refugees. The Israeli army clashed with civilian protestors and injured 8 civilians. (ii) At 14:00, a public march set out in the village of Beit Sourik in

commemoration of the 60th anniversary of the Nakba. Civilian protestors carried UN banners and demanded the implementation of

UN resolutions related to the right of return of Palestinian refugees. • Wall Gates:
(a) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.
(b) The Israeli army continues to deny civilian access through the Wall gate on al-Shayyah road in the area between the villages of al-Sawahira al-Sharqiya and al-Sawahira al- Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
• Wall Construction: Wall construction continues in Dahiyat al-Bareed, Dahiyat al-Aqbat, from the village of Hizma to 'Anata, along the Hizma-Jaba' road, the area of al-'Eizariya to al-Shayyah, from the village of Beit Surik to Biddu, in the areas of al-Judeira, Bir Nabala, and Beit Hanina, west of the village of al-Jib, and in the vicinity of the village of Qatanna.
Closure of Main Roads:
(i) The Israeli army continues to close with dirt barricades the eastern entrance to the village of Sinjil.
(ii) The Israeli army continues to close with cement blocks the western entrance to the village of Safa.
(iii) The Israeli army continues to close with cement blocks the entrance to the village of Ras Karkar.
(iv) The Israeli army continues to close the road connecting the villages of Ras Karkar and Kharbatha Bani Hareth, the western entrance to the village of Ain Yabroud, and the junction of Kafr Malik – Ein Samiah with dirt barricades and cement blocks.
• <u>Checkpoints</u> : The Israeli army continues to intensify restrictions at the checkpoint set up on the overpass to the town of 'Atara and impede civilian access.
• Flying Checkpoints : At 10:30, the Israeli army set up a checkpoint on the entrance to the town of Silwad, and searched civilians and vehicles.
• Raids: (i) At 13:15, the Israeli army raided the village of Ramon and searched the house of civilian Abdel Hamid al-Rahman al-Kuhleh. In addition, the Israeli army stole \$6000 from the house and the house owner lodged a complaint at the police station.
(ii) At 23:15, the Israeli army raided the city of al-Bireh and patrolled it until 00:15.At 01:30, the Israeli army raided the village of Ramon and searched a number of civilian houses.
(iii) At 00:30, the Israeli army raided the village of Deir Nizam, searched 1 civilian house, and arrested 1 child.
(iv) At dawn on May 15, the Israeli army raided the village of Kharbatha Bani Hareth and clashed with civilians during search of 1 civilian house, and injured 2 civilians.
Arrests: The civilian arrested in the village of Deir Nizam is called Ala Farhoud Nimer al-Tamimi, 17.

	 <u>Settler Violence</u>: At 01:40, a bunch of settlers attacked a civilian called Hussein Kaabneh who lives in a tent near the area of Ein Samia and asked him to leave. In addition, the settlers set crops to fire and injured him. <u>Wall Construction</u>: Wall construction continues in the area west of the town of 'Abud as well as in the areas of al-Midya to Ni'lin and Ni'lin to Deir Qaddis.
JENIN	 Closure of Main Roads: The Israeli army continues to close with dirt barricades the road leading to the town of 'Arraba east of the settlement of Dotan. Raids: (i) At 23:00, the Israeli army raided and patrolled the village of Zebouba. (ii) At 03:00, the Israeli army raided and patrolled the city of Jenin. Wall Gates: Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.
TOUBAS	 Checkpoints: The Israeli army continues to close Tayasir checkpoint east of the town of Tubas, denying civilian access to the Northern Jordan Valley, except for civilians whose IDs indicate that their place of residence is the Northern Jordan Valley. Flying Checkpoints: At 09:00, the Israeli army set up a checkpoint in the area of al-Sairafi east of the city of Nablus, and searched civilians and vehicles. Raids: The Israeli army raided and patrolled the village of Tayasir. Setter Violence: At 10:30, a bunch of settlers attacked a civilian called Khaled Rushdi Daghlas while he was near his land that is near the evacuated Homesh settlement.
TULKAREM	 Closure: The Israeli army continues to declare the district of Tulkarem a closed military zone and to impede civilian access to and from the district. Closure of Main Roads: (a) The Israeli army continues to close with dirt barricades the Dahiyat Iktaba-Bal'a road; the entrance to the village of Saffarin; the road connecting the town of Deir al Ghusun to 'Attil's plain; the road to the town of Deir al-Ghusun's plain; and the entrance to the village of 'Izbat Abu Khamis. (b) At 20:00, the Israeli army closed the road connecting the villages of Ramin and Bazaria with dirt barricades. (c) At 17:00, the Israeli army closed the northern entrance to the town of 'Azzun with barbed wires. Checkpoints: The Israeli army continues to intensify restrictions at Einav checkpoint that is set up on Tulkarem-Nablus road and at Jubaa checkpoint. Flying Checkpoints: At 09:10, the Israeli army set up a checkpoint on the entrance to the town of 'Allar, and searched civilians and vehicles. Demonstrations: At 11:00, a public march set out in the city of Tulkarem in commemoration of the 60th anniversary of the Nakba. Civilian protestors carried UN banners and demanded the implementation of UN resolutions

- (iii) Beginning on 23 November 2006, the Israeli army continues to close the checkpoint set up in the area between the city of Nablus and the town of 'Asira al-Shamaliya and to prevent civilians from crossing, only allowing access to humanitarian cases.
- (iv) Since 06:10, the Israeli army closed the checkpoint that is set up on the road connecting the city of Nablus and the town of Aseera al-Shimaliyyeh, and impeded traffic.
- <u>Flying Checkpoints</u>: At 07:30, the Israeli army set up a checkpoint on al-Badhan road (eastern entrance to the city of Nablus), and searched civilians and vehicles.
- <u>Raids</u>: At 02:10, the Israeli army raided the city of Nablus and the refugee camp of Balata, searched a number if civilian houses, arrested 1 civilian, and withdrew at 05:20.
- <u>Arrests</u>: The civilian arrested_in the city of Nablus is called Ghanem Tawfiq Sawalmeh.
- <u>Demonstrations</u>: At 10:00, a public march set out in the city of Nablus in commemoration of the 60th anniversary of the Nakba. Civilian protestors carried UN banners and demanded the implementation of UN resolutions related to the right of return of Palestinian refugees. The Israeli army clashed with civilian protestors near Huwara checkpoint and injured 4 civilians.

• Closure of Main Roads:

- (i) The Israeli army continues to close the main north-western entrance to the city of Salfit with dirt barricades since the beginning of the current *Intifada* (Uprising).
- (ii) The Israeli army continues to close with dirt barricades the western entrance to the village of Marda and Hares. In addition, the Israeli army continues to close the eastern entrance to the village of Yassouf and the southern entrance to the village of Deir Istiyya with dirt barricades, as well as the southern entrance to the town of Kafl hares and the 2 northern entrances to the town of Bruqin and the village of Qarawa Bani Hassan.
- (iii) At 21:50, the Israeli army removed the dirt barricade set up at the western entrance to the village of Marda.
- <u>Checkpoints</u>: The Israeli army continues to intensify its restrictions at Deir Ballut and Za'tara checkpoints and prevent civilian vehicles from traveling towards the town of Kafr al-Dik. At 17:00, the Israeli army closed Za'tara checkpoint and impeded traffic upon the arrest of a civilian under the pretext of finding a suspicious object with him. The checkpoint was reopened at 17:40.

• Flying Checkpoints:

- (i) At 10:30, the Israeli army set up a checkpoint near the junction of Ariel settlement.
- (ii) At 15:35, the Israeli army set up a checkpoint on the road that connects the town of Kafl Hares and the village of Zeita Jama'in, and searched civilians and vehicles.

• Closure:

- (i) The Israeli army continues to close the following locales in the old city of Hebron: al-Shuhada' Street and the area of al-Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al-Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of al-Khan with an electronic gate, isolating the area from al-Laban Market and the area of al-Sahleh. The Israeli army also continues to install an iron gate at the entrance to the area of al-Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.
- (ii) Although it expired on 07 May 2006, the Israeli army continues to implement a military order stipulating the prohibition of civilian vehicles from traveling along the road connecting the settlement of Kiryat Arba' to the Ibrahimi Mosque in the old city of Hebron unless they possess access permits.

• Closure of Main Roads:

- (i) The Israeli army continues to close with dirt barricades the following locales: the entrance to the town of al-Samoa'; the area of al-Hawawir leading to the town of Halhoul; the area of al-Fahs south of the city of Hebron; the junction to the area of Farsh al-Hawa leading to Road # 35 northwest of the city of Hebron; the road connecting the town of Surif to the village of al-Jab'a; the entrance to the village of Beit 'Einun; and the eastern entrance to the village of Kharsa. The Israeli army also continues to close with cement blocks the entrance to al-Qeisi neighborhood in the old city of Hebron as well as the main entrance to al-'Arroub refugee camp.
- (ii) In accordance with Military Order # 378, the Israeli army continues to prohibit Palestinian vehicles from traveling along Shalala Old Street that leads to the old city of Hebron, only allowing Israeli vehicles as well as Israeli army vehicles to travel along this street.

- (i) At dawn on May 14, the Israeli army raided the village of Khirbet al-Kom, searched 1 civilian house, and arrested 1 civilian.
- (ii) At dawn on May 14, the Israeli army raided the town of al-Thahiriyyeh and arrested 1 civiian.
- (iii) At 20:00, the Israeli army raided the townof Sa'ir, clashed with

civilians and injured and arrested 1 child.

- Wall Construction: Wall construction continues in the section of Tarqumiya checkpoint terminal, the remaining section of the Wall route that separates the settlement of Eshkolot from the village of al-Ramadin, and near the village of Imneizil southeast of the town of Yatta.

PRISONBERS CONDITIONS

- The Israeli military court at Ofer military detention camp sentenced prisoner Mohammad Ismail Samamra, from the city of Ramallah, for 10 months imprisonment, and prisoner Abdel Aziz Malik Hweihi, from the village of Ein Yabroud in Ramallah district, for 24 months in jail.
- The Israeli military court at Salem detention camp sentenced prisoner Safwat Mohammad Odeh for 10 months in jail and a fine of 2000 shekels equivalent to 560 dollars. In addition, the court extended the administrative detention of 10 prisoners from Tulkarem district.
- The Israeli military court at Ofer detention camp sentenced prisoner Iyad Kamel Eid al-Kamel, from the city of Bethlehem to 4 years in jail and a fine of 10,000 shekels equivalent to 2800 dollars.
- The Prisoner's Club and the family of prisoner Zakaria Mohammad Ata Ammar who is detained in the Negev jail appealed to human rights institutions and the international community to rescue his life as a result of the raid deterioration in his health following a surgery on Jordan.
