MONTHLY SUMMARY OF ISRAELI VIOLATIONS*

01 June 2007 - 30 June 2007

The following summary table and overview of events is a survey of Israeli violations during the period 01 June 2007 to 30 June 2007. The report includes a summary table of events by type throughout the West Bank and Gaza Strip, in addition to a comparative table surveying events over the past three months. The survey is compiled from Daily Situation Reports of the Palestinian Monitoring Group (PMG), Negotiations Affairs Department, Palestine Liberation Organization. The PMG monitors all aspects of ground conditions in the West Bank and Gaza Strip, including Israeli violations, Palestinian violations, and Palestinian achievements. The PMG Daily Situation Reports are a survey of daily events collated from information provided by Palestinian Authority civilian ministries and security agencies. The information reported through the PMG process only represents data available at the time of distribution.

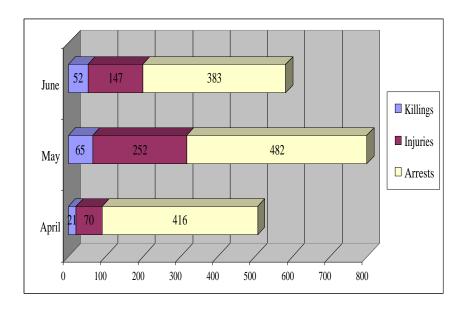

SAMPLE OF ISRAELI ARMY KILLINGS DURING THE MONTH OF JUNE 2007

- On 01 June, the Israeli army opened fire towards civilians northwest of the town of Beit Lahiya, killing 2 children and injuring another.
- On 06 June, the Israeli army raided the city of Hebron and opened fire towards a house, killing 1 elderly civilian and injuring 5 civilians, including 3 female civilians. Of those injured, a female civilian was in critical condition.
- On 10 June, *Mahir 'Ata Dandan*, a political prisoner, died in Galboa' Prison as a result of Israeli deliberate medical negligence. Of a 16-year sentence, Dandan served 5 years in prison. With Dandan, the medical negligence related-death toll amongst Palestinian political prisoners rose to 44. According to the Palestinian Ministry of Prisoners' Affairs, 189 political prisoners have died in Israeli prisons.
- On 11 June, an Israeli settler vehicle ran over a 14-year-old child along the main road in the centre of the town of Huwwara in the district of Nablus, leaving him with injuries and contusions.
- On 14 June, Israeli Special Forces, supported by 9 Israeli army jeeps, raided the village of Seida in the district of Tulkarem. While surrounding and searching 2 houses, the Israeli army opened fire, killing 1 civilian and injuring 2 others, including 1 child.
- On 14 June, the Israeli army opened fire and fired 1 tank shell from one of its locations on the Green Line towards the area of Ash Shuka east of the city of Rafah, killing 5 children, including 2 brothers, and injuring 6 others.
- On 15 June, an Israeli settler ran over and killed a civilian near the junction to the village of Beita in the southern Nablus district.
- On 22 June, the Israeli army set up a flying checkpoint on the overpass to the town of Halhul north of the city of Hebron, searched civilians and vehicles, and opened fire towards civilian houses, killing 1 civilian.
- *Ahmed Dawoud 'Aqel*, 67 years old, died of injuries sustained, after an Israeli settler vehicle ran over him near the village of Kafr Qaddum in the district of Qalqiliya on 02 June 2007.
- In the evening on 26 June, the Israeli army, covered by combat helicopters, raided the city of Nablus as well as the refugee camps of Balata, 'Askar, and 'Ein Beit el Ma' and opened intensive fire. Confrontations took place between the Israeli army and civilians, during which the Israeli army injured 13 civilians, including 4 children. While pursuing a civilian in the city, the Israeli army opened fire, killing a civilian bystander. At noon on 30 June 2007, the Israeli army withdrew from the city and refugee camps.

ANALYSIS OF EVENTS

1. Assassinations

An Israeli UAV fired 2 missiles towards a civilian vehicle in the city of Khan Yunis, extra-judicially killing 2 armed Palestinian individuals and 1 Palestinian security officer. The Israeli air attacks also resulted in the injury of 1 child and 1 civilian bystander.

2. Deaths

The Israeli army killed **49 Palestinians in June**, including 13 Palestinians in the West Bank and 36 in the Gaza Strip. The Israeli army killed Palestinians in the following districts: Jerusalem (1); Jenin (3); Tulkarem (1); Qalqiliya (2); Nablus (3); Hebron (3); Northern Gaza (5); Gaza (12); Central Gaza (5); Khan Yunis (8); and Rafah (6). Of these, the Israeli army killed 10 children. In addition, a 67-year-old civilian died of injuries sustained after an Israeli settler vehicle ran over him near the village of Kafr Qaddum in the district of Qalqiliya. Moreover, an Israeli settler vehicle ran over and killed a civilian near the junction to the village of Beita in the district of Nablus. Another civilian also died, while he was stranded on Beit Hanun (Erez) Crossing in the district of Northern Gaza. Additionally, a political prisoner died in Galboa' Prison as a result of deliberate medical negligence. The Israeli army also killed 21 armed Palestinian individuals.

3. Injuries

The total number of injuries reported during the month of June was **147** (72 Palestinians in the West Bank and 75 in the Gaza Strip). Of those injured, 24 were children (including 1 child run over by an Israeli settler vehicle and 1 child as a result of Israeli settler violence); 6 female civilians; a deaf civilian; 5 civilians from the same family; 4 international peace activists; 1 Palestinian security officer; and 6 armed Palestinian individuals. In addition, the Israeli army injured 3 civilians, while they were stranded on Beit Hanun (Erez) Crossing. An Israeli settler vehicle also ran over and injured 1 civilian.

4. Arrests

The Israeli army arrested **383** Palestinians in June, including 342 Palestinians in the West Bank and 41 in the Gaza Strip. The majority of arrests were reported to have taken place in the districts of Nablus (69), Hebron (62), and Jenin (46). Among these, the Israeli army arrested 14 children (including 1 female child, claiming that she attempted to stab an Israeli soldier); 1 female civilian; 4 injured civilians; 10 university students (including 1 university female student, allegedly for locating a dagger in her possession); a municipality chairman; and 25 Palestinian security officers. In addition, Israeli troops positioned on Al Karama (Allenby) Bridge on the Jordanian border arrested 5 civilians.

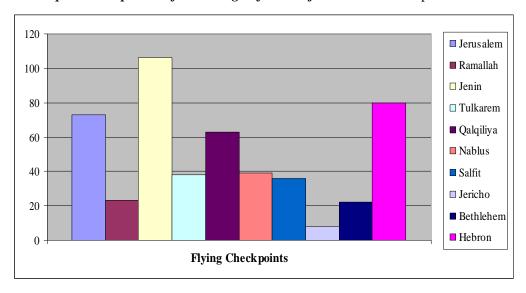
5. Closure

Especially on Fridays, the Israeli army has continued to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem and prevented civilians from accessing the Al Aqsa Mosque compound. Beginning on 17 April 2006, the Israeli army has continued to intensify its restrictions at permanent checkpoints set up throughout the West Bank districts, after a Palestinian individual carried out a suicide attack in the city of Tel Aviv inside the Green Line, as well as to isolate the northern districts from the central and southern districts of the West Bank, impeding civilian movement between these districts. Israeli troops positioned at the **Za'tara junction checkpoint** also continued to impede access to civilian residents of the northern districts travelling towards the central districts of the West Bank. The Israeli army also intensified its restrictions at 'Einav and Jubara checkpoints (the eastern and southern entrances to the city of Tulkarem respectively), impeding civilian access. Additionally, the Israeli army continued to intensify its restrictions at all checkpoints set up at the entrances to the city of Nablus. Moreover, the Israeli army continued to isolate the area of the Jordan Valley from the rest of the West Bank. Israeli troops positioned at Tayasir and Al Hamra checkpoints as well as the checkpoint set up west of the village of Al 'Auja continued to impede access to

civilian residents of the districts of Jenin, Nablus, Ramallah, and Jericho into the Jordan Valley.

Special permits are still required for private civilian vehicles to cross *Huwwara* and *Beit Iba checkpoints* at the entrances to the city of Nablus and for vehicles leaving the city of Jericho through the *checkpoint set up at the southern entrance to the city* as well as through *Ma'ale Efrayim*, *Al Hamra*, and *Al 'Auja checkpoints* leading to the area of the Jordan Valley. Considering it a "border crossing point", the Israeli army continued to prevent Palestinian civilian vehicles from the West Bank from crossing *Qalandiya checkpoint* towards the towns of Ar Ram and Qalandiya as well as Dahiyat al Bareed north of the city of Jerusalem.

Further impeding civilian access, the Israeli army set up **488 flying checkpoints** in and around Palestinian residential locales throughout the West Bank during the month of June, compared to 473 flying checkpoints in May and 585 in April.



Additionally, the Israeli army closed **38 roads, junctions, and entrances** to Palestinian residential areas throughout the West Bank. The Israeli army has also continued to close the commercial centre in the old city of Hebron for an extended period of time.

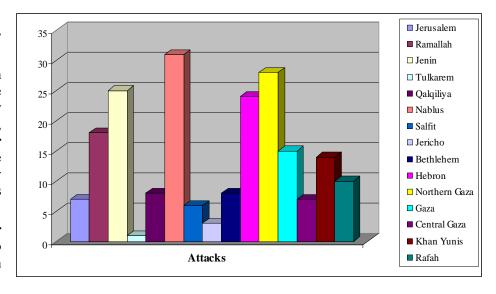
The Israeli navy also continued to impose an intensified sea blockade on the coast of the Gaza Strip and prevent Palestinian fishing boats from sailing.

6. Attacks

A total of **205 attacks** were reported during the month of June, including **131** attacks in the West Bank and **74** in the Gaza Strip.

The Israeli army carried out **98 attacks during raids** into Palestinian residential areas, **45 attacks during confrontations** between the Israeli army and Palestinians, and **39 attacks from Israeli army military posts** towards civilian houses and property. In addition, Israeli combat aircraft, helicopters, and UAVs carried out **13 air attacks**. Israeli combat helicopters also opened machinegun fire towards Palestinian territory on **4 occasions**. Furthermore, Israeli navy boats carried out **5 attacks** and Israeli settlers opened fire towards Palestinians on **1 occasion**.

In addition, the Israeli army carried out **74 attacks** (**including air attacks**) in the Gaza Strip districts. Armed Palestinian individuals also fired 196 mortars towards the Green Line. Of these, 7 Palestinian mortars landed on Palestinian territory.

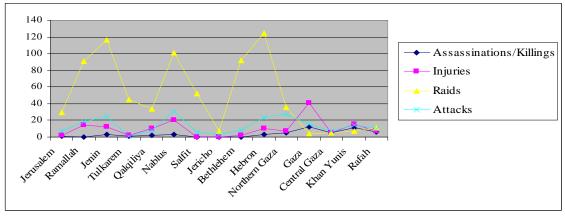


7. Raids

The Israeli army carried out a total of **756 raids** into Palestinian residential locales during the month of June, including **693 in the West Bank** and **63 in the Gaza Strip.** The majority of Israeli army raids took place in the districts of Hebron (125), Jenin (116), Nablus (101), Bethlehem (92), and Ramallah (91). The

Israeli army opened fire during 98 of the 756 raids, approximately 13% of the total number of raids into Palestinian residential areas. Additionally, the Israeli army imposed curfew 11 times over 7 residential locales in the West Bank during raids (compared to 14 times in May and 17 in April). The Israeli army also occupied and converted into military posts 48 civilian houses and residential buildings, including 14 in the city of Nablus.

The chart to the right shows the correlation between the number of raids & resulting human losses.



Following the crisis in the Gaza Strip, the Israeli-Palestinian ceasefire agreement that entered into force at 06:00 on 26 November 2006 has no longer been effective.

The Israeli army also continued to intensify its raids on Palestinian Authority controlled territory (**Areas "A"** under the Oslo Agreement, which the Israeli army has continued to reinvade since 2002). The Israeli army conducted **383** of the 756 raids, approximately 50.7% of the total number of raids, into Palestinian Authority controlled territory in the West Bank.

Following the Sharm ash Sheikh Summit (08 February 2005), security control of **the city of Jericho and the village of Al 'Auja** was transferred back to the Palestinian Authority on 16 March 2005. On 21 March 2005, security control of **the city of Tulkarem and its eastern areas** was also transferred back to the Palestinian Authority. Palestinian and Israeli commanders agreed that the Israeli army would not enter these areas. However, **the Israeli army violated the agreement as it raided** the city of Jericho as well as 'Aqbat Jaber refugee camp on **2 occasions** and the village of Al 'Auja on **5 occasions**. Since 13 July 2005, the Israeli army has continued to reinvade the city of Tulkarem and its suburbs, as well as Nur Shams and Tulkarem refugee camps, and carried out **17 raids** into the area in June. The Israeli army also raided the eastern areas of the city of Tulkarem on **11 occasions**.

8. House Demolitions

During the month of June, the Israeli army demolished 4 civilian houses in the West Bank. Of these, the Israeli army demolished 2 houses in the city of Jerusalem, claiming that they were built without the required construction licences. The Israeli army also demolished 2 other houses during large-scale raids into the old city of Nablus and the town of Khuza'a in the district of Khan Yunis.

The Israeli army also distributed notices for the demolition of 12 houses in the district of Salfit, including 11 houses in the village of Yasuf alone.

9. Provocation of Palestinian Military and Security Forces

The Israeli army carried out 21 incidents of attacking and provoking Palestinian security and military forces and posts during the month of June. All these incidents were reported to have taken place in the West Bank, as follows:

10. Attacks on Public and Private Property

A total of **72 incidents of destruction and confiscation of public and private property** were reported during the month of June, including 42 in the West Bank and 30 in the Gaza Strip.

In the city of Nablus, the Israeli army used explosives and damaged 14 civilian houses. The Israeli army also searched dozens of civilian houses and damaged their furniture in the districts of Jenin, Tulkarem, Nablus, Hebron, Gaza, and Central Gaza. During air attacks, the Israeli air force destroyed 2 civilian vehicles in Gaza city as well as another vehicle in the city of Khan Yunis. In addition, the Israeli army damaged 1 civilian vehicle in the district of Jenin; burned crops and olive trees near a settlement and a settlement outpost in the district of Qalqiliya; destroyed agricultural crops in the districts of Northern Gaza, Gaza, Khan Yunis, and Rafah; dismantled greenhouses east of the city of Khan Yunis; demolished the wall of a school in the district of Khan Yunis; levelled a road in the eastern Rafah district; and disconnected telephone lines in the city of Nablus. Furthermore, the Israeli army damaged 4 electricity transformers in the districts of Jenin, Nablus, and Khan Yunis; set fire to a restaurant in the city of Nablus as well as a barracks in the district of Jenin; forced civilians to close their commercial shops in the village of Far'un in the district of Tulkarem; disrupted the transmission of local television and radio stations and broadcast Israeli statements in the city of Nablus; and carried out excavations in search of archaeological artefacts in the area surrounding the village of Al Walaja in the district of Bethlehem. Additionally, the Israeli army demolished the DCO offices and buildings in the district of Northern Gaza and destroyed 2 blacksmiths' workshops in the districts of Gaza and Central Gaza.

Moreover, the Israeli army confiscated 1 Kalashnikov rifle and 1 pistol from Palestinian Police officers, while they were guarding a hospital in the city of Nablus. The Israeli army also confiscated 1 hunting rifle from a civilian in the district of Salfit as well as 5 rifles and several pistols in the districts of Hebron and Rafah.

11. Settlement Activity

A total of 4 incidents of settlement activity were reported to have taken place in the West Bank during the month of June.

12. Settler Violence

Israeli settlers carried out 34 incidents of violence in the West Bank districts during the month of June.

Israeli settler vehicles ran over and killed 2 civilians, including an elderly civilian, in the districts of Nablus and Qalqiliya as well as injured 1 child in the district of Nablus. Israeli settlers also beat 1 civilian in the district of Qalqiliya as well as family members and a child in the old city of Hebron. In addition, Israeli settlers took a 10-year-old child to an Israeli Police station; repeatedly threw stones and garbage at civilians; broke the windshield of a vehicle; raided a

village using Police dogs; destroyed 8 tombstones; threw stones at civilian houses; and verbally assaulted Muslims and the Prophet Mohammed (may peace be upon him) in the district of Salfit. Furthermore, Israeli settlers raided 2 houses; attempted to assault civilians in a village in district of Hebron; fired sound grenades towards civilian houses in the district of Qalqiliya; attacked a house and cut down trees in the district of Nablus; and attempted to seize control of civilian land, beat civilians, damaged trees, and extracted water from a well near the settlement of Sussia in the district of Hebron. Additionally, Israeli settlers took position on the debris of the evacuated settlement of Homesh on several occasions; set fire to hundreds of *dunums* of olive groves in the district of Tulkarem, Qalqiliya, and Nablus; and uprooted olive trees on civilian land and replanted them along the road to a settlement outpost in the district of Nablus.

13. Medical Obstruction

In June, the Israeli army carried out **9 incidents of medical obstruction**, including 6 in the West Bank and 3 in the Gaza Strip. The Israeli army took positions in front of 3 hospitals in the city of Nablus; prevented ambulances from evacuating injured civilians in the districts of Jenin, Gaza, and Khan Yunis; impeded access to other ambulances to transport injured civilians in the district of Jenin; and detained 1 ambulance in the city of Nablus.

14. Attacks on Religious Sites

The Israeli army surrounded 1 mosque in the city of Jerusalem, while worshippers were performing evening prayers. The Israeli army also surrounded another mosque in the city of El Bireh in the district of Ramallah.

15. School Disruption

The Israeli army carried out **9 incidents of school disruption** during the month of June, including 8 in the West Bank and 1 in the Gaza Strip. The Israeli army occupied and converted into a military post 1 school in the district of Khan Yunis; searched 1 kindergarten and 1 private school in the districts of Tulkarem and Hebron; and took a position in front of a school, while students were sitting for high school matriculation examinations. In the districts of Bethlehem, Ramallah, and Hebron, the Israeli army also detained a number of school teachers and students, while they were going to attend high school matriculation examinations. In addition, the Israeli army took a position in front of the Palestinian Ministry of Education District Office in the city of Hebron.

16. Closure of Crossing Points

The Israeli army completely closed crossing points in the Gaza Strip, including crossing points into the Green Line, on 135 occasions this month. The Israeli army closed crossing points into the Green Line on 86 occasions. *Beit Hanun (Erez) Crossing* was closed for 15 days. Following the crisis in the Gaza Strip, however, the Israeli army has only allowed access to certain humanitarian cases, after prior coordination. The Israeli army also closed *Al Muntar (Karnei) Commercial Crossing* for 19 days completely and 2 days partially; *Ash Shuja'iya (Nahal 'Oz) Crossing* (designated for fuel transportation) for 6 days completely and 12 days partially; *Sufa Crossing* (designated for construction cargo transportation) for 25 days; and *Karm Abu Salim (Karem Shalom) Crossing* (designated for commercial trading with Egypt) for 21 days completely and 6 days partially for transportation of food and medical supplies. Additionally, the Israeli army closed international crossing points on 49 occasions, including *Rafah Crossing* for 19 days completely and 1 day partially to arrivals only. 150 civilians, who were stranded on the Egyptian border, entered the Gaza Strip. *Yasser Arafat International Airport* (closed for 30 days) remains closed since the outbreak of the current *Intifada* (Uprising).

17. Palestinian Security Measures

During the month of June, Palestinian security forces carried out **5 security measures** in the West Bank. Palestinian security forces handed over to the Israeli army (through the DCO) 2 Israeli settlers, who were captured while they were attempting to access a synagogue in the city of Jericho, without prior coordination with the Palestinian authorities. Palestinian security forces also handed over an Israeli settler, who was apprehended after he entered the city of Nablus. In addition, Palestinian security forces handed over to the Israeli army 2 illegal vehicles, seized in the cities of Tulkarem and Hebron.
