GAZA STRIP

At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles. Israeli forces broke the cease fire agreement by opening fire from their positions **ALL** behind the Green Line towards Gaza. **DISTRICTS** Israeli forces broke the cease fire agreement by opening fire and firing tank artillery shells from their positions behind the Green Line towards North Gaza and Gaza. Israeli Fighter Jets broke the ceasefire agreement by launching several missiles during 7 consecutive air strikes towards North Gaza, Central Gaza, Khan Yunis and Rafah and as a result killed a 4 year old child and injured 7 others including women and children Palestinian gunmen broke the cease fire agreement by opening fire and launching projectiles towards Israeli forces near the border fence. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businessmen and passengers travelling abroad through Al-Karama crossing with previous coordination. Attack: (i) On the afternoon of December 24th 2013, Israeli forces positioned behind the Green Line opened fire towards several residents located near the **NORTHERN GAZA** border fence in Beit Lahiya and injured a resident. (ii) On the afternoon of December 24th 2013, Israeli forces positioned behind the Green Line fired tank artillery shells towards agricultural land in Beit Lahiya. Air Assault: On the afternoon of December 24th 2013, Israeli fighter iets launched several missiles towards Palestinian gunmen in Al-Atarat area in Beit Lahiya. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has been closed following a unilateral Israeli decision. Attack: On the afternoon of December 24th 2013, Israeli forces positioned behind the Green Line fired several tank artillery shells towards Al-Shuja'iya **GAZA** neighbourhood in east Gaza and as a result injured 3 residents. **Palestinian Attack:** At 11:15, Palestinian gunmen opened fire and launched 3 projectiles towards Israeli military vehicles located near the border fence in east Gaza and as a result killed 1 Israeli soldier after critically injuring him during which Israeli forces opened fire towards agricultural land after raiding it while escorting several military bulldozers. Air Assault: (i) On the afternoon of December 24th 2013, Israeli fighter jets launched several missiles towards Palestinian gunmen in Al-Buriej camp. (ii) On the afternoon of December 24th 2013, Israeli fighter jets launched **CENTRAL** several missiles towards a home in Al-Maghazi camp and as a result killed **GAZA** a 4 year old child and injured 3 others including a woman and 2 children. (iii) On the afternoon of December 24th 2013, Israeli fighter jets launched 3 missiles towards Palestinian gunmen in Al-Baraka area in Deir Al-Balah.

Killing: Hala Al-buheri (4 years old) was killed by Israeli airstrikes in Al-Maghazi

camp.
