	 Closure: The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 40 from conducting prayers at Al-Aqsa mosque compound. The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. Closure of Main Roads: The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village. The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
JERUSALEM	 Checkpoints: Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall. Detention: On May 30th 2015, Israeli forces positioned in Al-Shiekh neighbourhood detained Ammar Abu Maliya and Wael Al-Najjar. At dawn on May 31st 2015, Israeli forces positioned in Ras Al-Amoud neighbourhood detained Ammar Al-Bazlamit after storming his home. Wall Gates: The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem
RAMALLAH &	 IDs to cross, after subjecting them to thorough searches using electronic devices. Closure of Main Roads: The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. Raid:

	an International tourist from Mexico.
	(iii) At 22:30, a group of Israeli settlers armed with sharp objects near Tel Al-
	Rumayda neighbourhood in the old city of Hebron assaulted three
	residents: Fadi Al-Taweel, Billal Salah and Hamada Abu Za'noun.
	(iv) At 03:35, a group of Israeli settlers stormed Tel Al-Rumayda
	neighbourhood in the old city of Hebron and set fire to the main door

GAZA STRIP

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza, Gaza and Rafah.

NORTHERN GAZA	 Closure of Crossing Point: Beit Hanun (Erez) is closed. Attack: At 04:00, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores Al-Sudaniya beach in west Beit Lahiya.
GAZA	 (i) Closure of Crossing Points: (ii) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (iii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. Attack: At 22:00, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores Gaza city. Detention: At 00:10, Israeli forces detained an unidentified resident as he attempted to climb the border fence into Israel from North East Gaza area.
RAFAH	 Closure of Crossing Points: Yasser 'Arafat International Airport remains closed. Rafah (Al 'Awdah) Crossing is closed. Sufa Crossing is closed. Karm Abu Salem (Karem Shalom) Crossing is closed. Attack: At 00:15 on May 30th 2015, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Rafah city.
