	(ii) On 05 January 2009, the Israeli authorities issued Military Order #
	S/02/09 on the closure of and denial of civilian access to the
	"demarcation area" along the Wall in the area surrounding the city of
	Jerusalem. Accordingly, local residents and civilians holding permits
	can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of
	military orders relating to land confiscation for Wall construction).
	(iii) Beginning on 02 April 2009, the Israeli army has continued to impose a
	blockade and deny civilian access to a hill located in an area between
	the village of Biddu and Beit Iksa due it its geographical significance as

SALFIT	<ul> <li><u>Closure of Main Roads</u>:         <ul> <li>The Israeli army continues to close with dirt barricades the northern entrance to the city of Salfit.</li> <li>The Israeli army continues to close with cement blocks and iron gates the northern entrance to the town of Bruqin and the western entrance to the town of Kafr Ad Dik.</li> </ul> </li> <li><u>Checkpoint</u>: The Israeli army continues to intensify its restrictions and impede civilian access at the Za'tara junction checkpoint. At 14:00, the Israeli army closed the checkpoint and denied civilian access, allegedly for investigation a suspicious object. The Israeli army reopened the checkpoint at a later time.</li> <li><u>Flving Checkpoints</u>:         <ul> <li>(i) At 16:50, the Israeli army set up a flying checkpoint at the entrance to the village of Iskaka and searched civilians and vehicles.</li> <li>(ii) At 21:30, the Israeli army set up a flying checkpoint, closed the iron gate installed at the entrance to the town of Kifl Haris, and denied civilian access. The land was confiscated pursuant to Military Order # 07/31/T.</li> <li>Closure of Main Roads: The Israeli army continues to close with dirt barricades the road of Beit Jala-Wadi Ahmad as well as a detour road east of the town of Beit Fajjar.</li> <li>Flving Checkpoints: <ul> <li>At 10:10, the Israeli army set up a flying checkpoint on the junction to the village of Jannata and searched civilians and vehicles.</li> <li>At 10:10, the Israeli army set up a flying checkpoint on the junction to the area of An Nashash (the southern entrance to the city of Bethlehem) and searched civilians and vehicles.</li> </ul> </li> <li>Raids: At 14:15, the Israeli army raided the city of Beth Jala and 'Ayda refugee camp. While patrolling the refugee camp, confrontations took place between the Israeli army and civilians.
